He also had enterprise-wide responsibility for operations and supply chain activity. Since joining Owens Corning in 2000, Mr. Sandri had several commercial roles with responsibility for the United States, Latin America, Canada, and Asia Pacific. Before Owens Corning, he worked at Dow Chemical in Latin America and the United States.

Mr. Sandri earned a degree in chemical engineering from the Federal University of Parana and studied business administration at the University of São Paulo.
