Public Notice of Dividend Paid on February 16, 2015 in accordance with IRC §6045B

On December 8, 2014 SandRidge Energy, Inc. announced that its Board of Directors declared a \$4.25 per share semi-annual dividend on its shares of 8.5% Convertible Perpetual Preferred Stock, CUSIP number 80007P 604, to be paid in cash on February 16, 2015 to holders of record on February 1, 2015.

The estimated character of this distribution was previously reported to be a nondividend distribution reportable in Box 3 of Form 1099-DIV. However, based on new and subsequently available information, all of the distributions are now estimated to represent taxable ordinary dividends reportable in Box 1a of Form 1099-DIV. This corrected notice supersedes the previous public notice.
