Global Net Lease, Inc. Announces Common Stock Dividend for Fourth Quarter 2015

NEW YORK, Sept. 25, 2015 /PRNewswire/ -- **Global Net Lease, Inc.** ("GNL") (NYSE: GNL) announced today that, pursuant to the prior authorization of its board of directors, GNL intends to pay monthly distributions at an annualized rate of \$0.71 per share or \$0.1775 per share on a quarterly basis. Distributions will be paid on a monthly basis to stockholders of record at the close of business on the 8th day of each month, payable on the 15th day of such month, in each case, unless such date is a non-business day.

Accordingly, on October 15, 2015, November 13, 2015 and December 15, 2015, GNL will pay a distribution of \$0.059166667 per share to stockholders of record at the close of business on October 8, 2015, November 6, 2015 and December 8, 2015, respectively.
