AbCellera and AbbVie Partner to Advance New Antibody Therapies

VANCOUVER, British Columbia--(BUSINESS WIRE)-- **AbCellera** (Nasdaq: ABCL) announced today that it has entered into a multi-year, multi-target strategic collaboration with **AbbVie** Inc. (NYSE: ABBV). The partnership will leverage AbCellera's antibody discovery and development engine to deliver optimized development candidates for up to five targets selected by AbbVie across multiple indications.
