

The special meeting will be conducted virtually, giving you the opportunity to attend the meeting online, using your smartphone, tablet or computer.

You will be able to view a live webcast of the meeting, ask the board questions and submit your votes in real time.

Even if you currently plan to attend the Agnico Meeting and vote during the live webcast, you are encouraged to vote your your Agnico Shares in advance of the well in advance of the proxy cut-off time at 10:00 a.m. (Toronto time) on November 24, 2021, so that your vote will be counted in the event you experience any technical difficulties or are otherwise unable to access the Agnico Meeting.

Appointing someone to be your Proxyholder

An additional step is required, if you appoint someone to be your proxy, other than the individual(s) named on the form of proxy or voting instruction form, you or your proxy will need register such proxyholder with Computershare by going to: https://

www.computershare.com/AgnicoEagle and following the other instructions set out in the joint management information circular and the form of proxy of voting instruction form that you received well in advance of the proxy cut-off time at10:00 a.m. (Toronto time) on November 24, 2021. Failure to do so will result in the appointed proxyholder not receiving login credentials.

Non-Registered Holders

Non-registered holders, holding shares through a broker or financial institution, should carefully follow the instructions set out on the voting instruction form and in the information circular. Please note that only registered shareholders and proxy holders are permitted to vote at the meeting. An additional step is required for nonregistered shareholder wishing to vote at the meeting. A non-registerd holder must appoint themselves as a proxyholder, and register by going to: https://www.computershare.com/ AgnicoEagle and following the other instructions set out in the accompanying joint management information circular and the voting instruction form well in advance of the proxy cut-off time at 10:00 a.m. (Toronto time) on November 24, 2021, otherwise the non-registered shareholder will be required to login as a guest.

Navigation

Voting

Once the voting is announced, click the voting icon on the left hand side.

To vote, simply select your voting direction from the options shown on screen and click **Submit**. A confirmation message will appear to show your vote has been received.

If you have additional control numbers to vote, | + | HAVE ADDITIONAL CONTROL NUMBERS click at the top to enter the additional credential.

To change your vote, simply click REFRESH VOTING RESOLUTIONS

Voting will remain open until the voting on the ballot is closed.
