SAN DIEGO, CALIFORNIA, October 10, 2017...Realty Income Corporation (Realty Income, NYSE: O), The Monthly Dividend Company®, today announced that its Board of Directors has declared the 568th consecutive common stock monthly dividend. The dividend amount of \$0.212 per share, representing an annualized amount of \$2.544 per share, is payable on November 15, 2017 to shareholders of record as of November 1, 2017. The ex-dividend date for November's dividend is October 31, 2017.
