

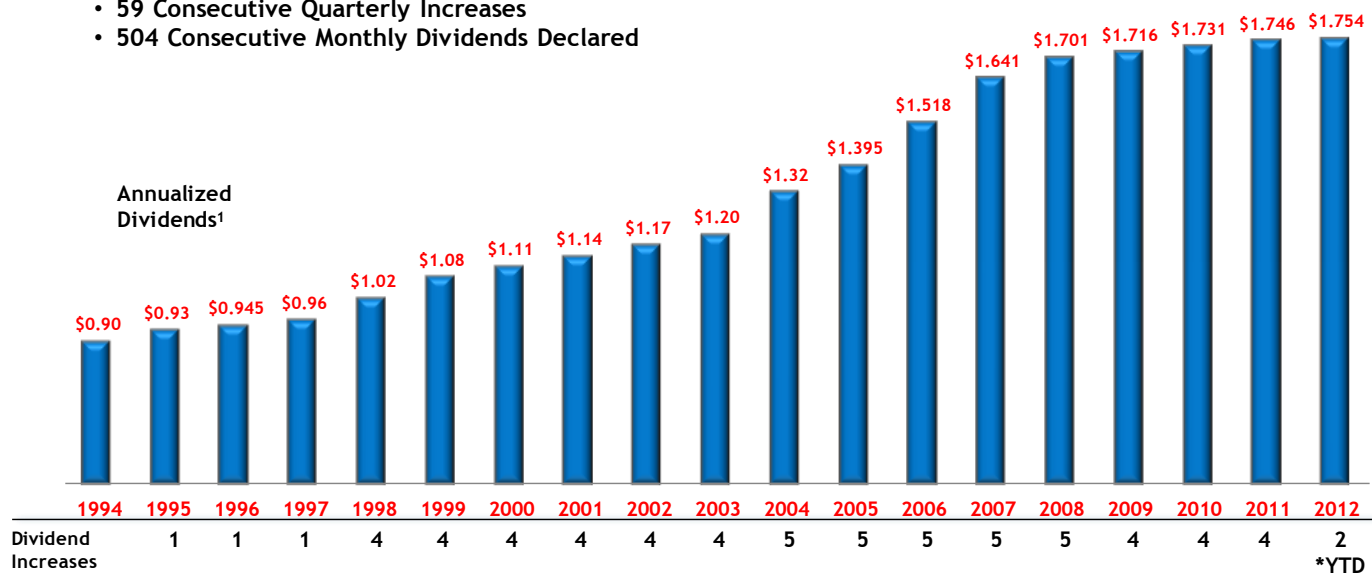

FOR IMMEDIATE RELEASE **66th COMMON STOCK MONTHLY DIVIDEND INCREASE DECLARED BY REALTY INCOME**

ESCONDIDO, CALIFORNIA, June 19, 2012....Realty Income Corporation (Realty Income), [The Monthly Dividend Company®](#), (NYSE:O), today announced that its Board of Directors has declared an increase in the Company's common stock monthly cash dividend to \$0.146125 per share from \$0.1458125 per share. The dividend is payable on July 16, 2012 to shareholders of record as of July 2, 2012. This is the 66th dividend increase, and the 59th consecutive quarterly increase, since Realty Income went public in 1994. The new monthly dividend amount represents an annualized dividend amount of \$1.7535 per share as compared to the previous annualized dividend amount of \$1.74975 per share. The Company continues its long-term policy of declaring and paying dividends on a monthly, rather than on a quarterly, basis. Tom A. Lewis, Chief Executive Officer of Realty Income commented, "We are pleased that our operations allow us to once again increase the amount of the dividend we pay to our shareholders. With the payment of the July dividend, we will have made 504 consecutive monthly dividend payments."
