REALTY INCOME DECLARES 493rd CONSECUTIVE COMMON STOCK MONTHLY DIVIDEND

ESCONDIDO, CALIFORNIA July 19, 2011....Realty Income Corporation (Realty Income), The Monthly Dividend Company®, (NYSE:O), today announced that its Board of Directors declared a common stock dividend of \$0.144875 per share, payable on August 15, 2011 to shareholders of record as of August 1, 2011. The dividend represents an annualized amount of \$1.7385 per share.

The Board of Directors also declared dividends on the Company's Monthly Income Class D and Class E preferred stock. The monthly dividends on the Class D and Class E preferred stocks are payable on August 15, 2011 to shareholders of record as of August 1, 2011. The monthly dividend amount on the Class D preferred stock is \$0.1536459 per share, for an annualized amount of \$1.84375 per share. The monthly dividend amount on the Class E preferred stock is \$0.140625 per share, for an annualized amount of \$1.6875 per share.

To date the Company has paid 492 consecutive common stock monthly dividends throughout its 42-year operating history and increased the dividend 62 times since Realty Income's listing on the New York Stock Exchange in 1994.
