REALTY INCOME INCREASES COMMON STOCK MONTHLY DIVIDEND 39th CONSECUTIVE QUARTERLY INCREASE

ESCONDIDO, CALIFORNIA, June 13, 2007.... Realty Income Corporation (Realty Income), The Monthly Dividend Company®, (NYSE:O) today announced that its Board of Directors has declared an increase in the Company's common stock monthly dividend to \$0.12775 per share from \$0.127125 per share. The new monthly dividend amount represents an annualized amount of \$1.533 per share. The dividend is payable on July 16, 2007 to shareholders of record as of July 2, 2007. This is the 39th consecutive quarter in which the Company has increased the amount of its monthly dividend and the 44th increase since Realty Income went public in 1994. The Company continues its long-term policy of declaring and paying common stock dividends on a monthly, rather than on a quarterly, basis.

Tom A. Lewis, Chief Executive Officer of Realty Income commented, "We are delighted to have been able to increase the amount of the monthly dividend again this quarter. With the payment of the July dividend, we will have made 444 consecutive monthly dividend payments. Our goal is to continue to provide consistent performance results and dependable monthly income to our shareholders. Increasing the amount of the dividend on a regular basis is the best evidence we can provide of our progress towards this goal."

Realty Income, The Monthly Dividend Company®, is a real estate company dedicated to providing shareholders with dependable monthly income. To date the Company has declared 444 consecutive monthly dividends throughout its 39-year operating history and increased the dividend 44 times since Realty Income's listing on the New York Stock Exchange in 1994. The monthly dividend is supported by the cash flow from over 1,990 retail properties owned under long-term lease agreements with leading regional and national retail chains. The Company is an active buyer of net-leased retail properties nationwide.
