## REALTY INCOME INCREASES COMMON STOCK MONTHLY DIVIDEND 37<sup>th</sup> CONSECUTIVE QUARTERLY INCREASE

ESCONDIDO, CALIFORNIA, December 13, 2006.... Realty Income Corporation (Realty Income), The Monthly Dividend Company®, (NYSE:O) today announced that its Board of Directors has declared an increase in the Company's common stock monthly dividend to \$0.1265 per share from \$0.125875 per share. The new monthly dividend amount represents an annualized amount of \$1.518 per share. The dividend is payable on January 16, 2007 to shareholders of record as of January 2, 2007. This is the 37<sup>th</sup> consecutive quarter in which the Company has increased the amount of its monthly dividend and the 42<sup>nd</sup> increase since Realty Income went public in 1994. The Company continues its long-term policy of declaring and paying common stock dividends on a monthly, rather than on a quarterly, basis.

Tom A. Lewis, Chief Executive Officer of Realty Income commented, "We are delighted to have been able to increase the amount of the monthly dividend again this quarter. With the payment of the January dividend, we will have made 438 consecutive monthly dividend payments. Our goal is to continue to provide consistent performance results and dependable monthly income to our shareholders. Increasing the amount of the dividend on a regular basis is the best evidence we can provide of our progress towards this goal."

Realty Income, The Monthly Dividend Company®, is a real estate company dedicated to providing shareholders with dependable monthly income. To date the Company has declared 438 consecutive monthly dividends throughout its 37-year operating history and increased the dividend 42 times since Realty Income's listing on the New York Stock Exchange in 1994. The monthly dividend is supported by the cash flow from over 1,900 retail properties owned under long-term lease agreements with leading regional and national retail chains. The Company is an active buyer of net-leased retail properties nationwide.
