



Clorox Declares Regular Quarterly Dividend of 96 Cents Per Share

OAKLAND, Calif., Sept. 18, 2018 /PRNewswire/ -- The Clorox Company (NYSE: CLX) today announced that its board of directors has declared a quarterly dividend of 96 cents per share on the company's common stock, payable Nov. 16, 2018, to stockholders of record as of the close of business on Oct. 31, 2018.

Total annual dividends paid to Clorox shareholders have increased each year since 1977.

The company also markets brands for professional services, including Clorox Healthcare® and Clorox Commercial Solutions®. More than 80 percent of the company's sales are generated from brands that hold the No. 1 or No. 2 market share positions in their categories.

Clorox is a signatory of the United Nations Global Compact, a community of global leaders committed to sustainability.
