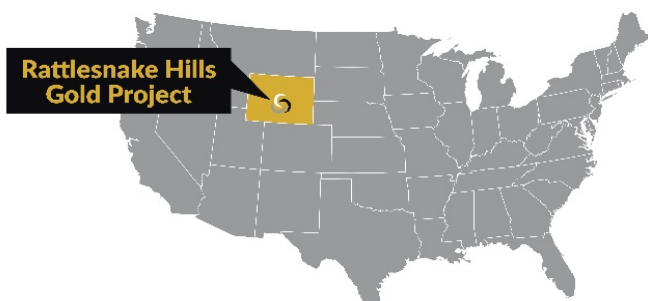

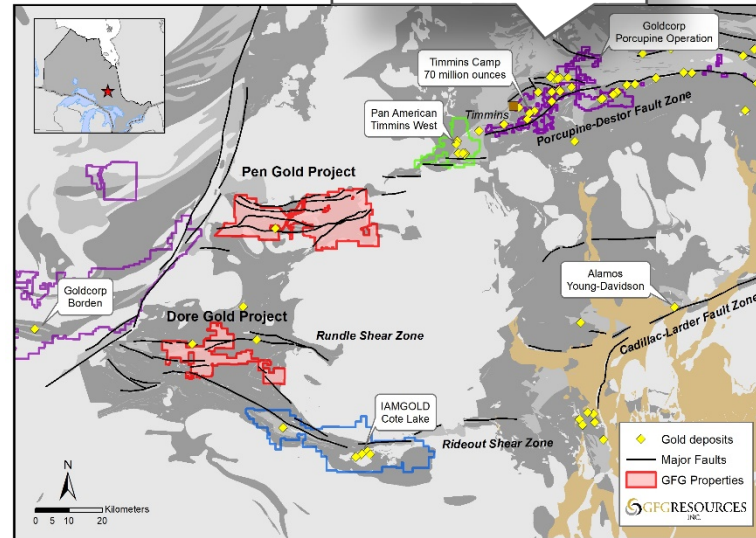

Proven Geology: Prospective Gold Belt

- 🎯 Project sits within the +1,500 km long belt of alkaline gold deposits on the east side of the Rocky Mountains
- 🎯 Similar geology to Cripple Creek, Wharf, Golden Sunlight: Consistent gold producers for multiple decades
- 🎯 100 km of historic drilling focused largely on 2 targets (North Stock & Antelope Basin) with impressive results:
 - Disseminated: **1.31 g/t Au over 405 m (from surface)**
 - High grade: **of 9.73 g/t Au over 56 m**
- 🎯 Deposits remain open in multiple directions & overall district remains untested
- 🎯 Currently under strategic review to find a path forward
