Dear Shareholders,

We entered 2022 with full confidence in our team and in our long-term strategic plan to drive sustainable growth and deliver shareholder value. Orthofix had solid operational execution in the face of challenges that included continued hospital staffing shortages and patients deferring care due to economic pressures. Despite these headwinds, we achieved some significant results including double digit growth in our global orthopedic business as well as early commercial traction of new spine biologics and fracture care products.

Growth was driven by several new products we introduced in 2022. These new products — the AccelStim™ bone-healing therapy for fresh fracture and nonunion fractures, TrueLok™ EVO, which added radiolucent rings and struts to our market-leading ring fixation system, and Galaxy Fixation Gemini™, our next-generation pin-to-bar system — have all been well received in the marketplace. We also launched two new biologic solutions in 2022 with our partnership with MTF Biologics, the Virtuos™ Lyograft, a shelf stable complete autograph substitute, and Legacy™, a demineralized bone matrix.

Our Merger

In 2022 we set our sights on a path to create a new larger global company through pursuing a merger of equals with SeaSpine. We are thrilled to have now completed the merger, creating an industry-leading global spine and orthopedics company with the power to drive sustainable top-tier growth and scale. I am very excited about the future of the organization for several reasons:

■ Together we have increased scale: The combined company will distribute products in 68 countries and will boast a workforce of approximately 1,600 employees, with experienced salesrepresentatives and a global R&D and manufacturing footprint.

- We have increased capabilities: The combination of our two organizations will deliver to our surgeons and their patients more comprehensive solutions that include biologics, innovative spinal hardware, bone growth therapies, specialized orthopedic limb lengthening and deformity solutions, and a leading surgical navigation system.

 We have the financial strength to invest in organic and inorganic innovation initiatives, including the combined company's deep pipeline, commercial channel expansion, and field inventory and instrumentation. The combination of our two businesses forms an extremely well-positioned spine and orthopedics company with a unique profile of scale, growth, and profitability.

Since joining Orthofix, I have truly been honored to lead this organization and its team of highly talented and dedicated employees.
