Second, employees completed a 78-question survey, including two open-ended questions, which looked at several elements of being an employee at Voya—including engagement and satisfaction, work environment, career development and remuneration. The results were analyzed and categorized according to eight core focus areas: leadership and planning; corporate culture and communications; role satisfaction; work environment; relationship with supervisor; training; development and resources; pay and benefits; and overall engagement.

"We have an amazing culture at Voya, which is a competitive advantage in our industry," said Michael Pratt, managing director, head of Human Resources for Voya Investment Management. "Our employees are passionate about serving our clients and giving back to the communities we live and work in. We are very proud of receiving this designation for the third straight year."
