# Owens Corning Earns No. 1 Ranking on 100 Best Corporate Citizens List for Second Year in a Row

The annual list recognizes the standout global environmental, social and governance (ESG) performances of the largest U.S.-based public companies. The companies are ranked based on a blend of performance and disclosure.

The 2020 100 Best Corporate Citizens ranking is based on 141 factors in eight pillars: climate change, employee relations, environment, finance, governance, human rights, ESG performance, and stakeholders and society. The list ranks companies in the Russell 1000 Index based upon research by ISS-ESG, the responsible investment research arm of Institutional Shareholder Services. Information for the ranking is compiled exclusively from publicly available resources and companies do not pay for the assessment.

It’s critical that we keep stretching ourselves, beyond what we thought possible, to broaden and deepen the impact of our work.
