[N]The rates in this tariff are being established in accordance with the Commission's January 20, 2022 order in Docket No. RM20-14-001, which reduced the index for the current five-year review period from PPI-FG + 0.78 percent to PPI-FG - 0.21 percent (the "March 2022 Index"). **To the extent that all or any portion of that order is reversed on rehearing or appeal and the index for the current five-year period is increased from the March 1 Index level, the Carrier reserves the right to collect from shippers the positive difference, if any, between the rates resulting from application of the March 2022 Index and the rates resulting from application of the new index, for all barrels shipped from March 1, 2022 forward.**

<sup>2</sup> **\*MEDIUM PETROLEUM** – Crude Petroleum with a viscosity from 20 up to but not including 100 centistokes at pumping temperature and a density greater than 25° API gravity up to and including 30° API gravity.

<sup>3</sup> **\*HEAVY PETROLEUM** – Crude Petroleum with a viscosity from 100 up to but not including 250 centistokes at pumping temperature and a density from 25° API gravity down to 21° API gravity.

<sup>4</sup> **\*SUPER HEAVY PETROLEUM** – Crude Petroleum with a viscosity from 250 up to and including 350 centistokes at pumping temperature and a density from 21° API gravity down to 19° API gravity.

\*Due to operational limitations, Carrier may limit the total volumes of Medium, Heavy, and Super Heavy Petroleum that can be nominated for transportation in a given month.

A Pump Over Fee of [I] \$0.1064 per Barrel will be charged on all Crude Petroleum Carrier receives from Express Pipeline, LLC and delivers into Rocky Mountain Pipeline System LLC.

Any Committed Shipper that fails to meet its Monthly Committed Volume will be subject to a 50.00 cents per Barrel charge for each deficient barrel.

**EXCEPTIONS AND ADDITIONS TO FRONTIER ASPEN LLC'S F.E.R.C. NO. 32. [W]6.0 4-9, OR REISSUES THEREOF.**

**ITEM NO. 25:** In addition to the provisions stated in Item No. 25, Variations in Quality and Gravity, of Frontier Aspen LLC's rules and regulations tariff, F.E.R.C. No. 32. [W]6.0 4-9, or reissues thereof, the following will apply to movements listed herein:

Rocky Mountain Sweet (RMS) Crude petroleum accepted for transportation under this tariff must meet the following specifications:

- Gravity of crude petroleum must be between 37 degrees and 41 degrees API.
- Viscosity up to but not including 20 centistokes at pumping temperature.
- Reid Vapor Pressure (RVP) must not exceed 9.6 psi.
- Hydrogen sulfide content must be below 10 ppm.
- Sulfur content must not exceed 0.30% by weight.
- Basic sediment and water (BS&W) content must not exceed 0.3% by volume and free water content must not exceed 0.3% by volume.

**ITEM NO. 35(c):** In addition to the provisions stated in Item No. 35(c), Measurement, Deductions, and Adjustments, of Frontier Aspen LLC's rules and regulations tariff, F.E.R.C. No. 32.6.0, or reissues thereof, the following will apply to movements listed herein:

Provided, however, the deduction on one-tenth of 1% (0.1%) to cover evaporation and other normal losses occurring during transportation shall not apply to Crude Petroleum Carrier receives from Express Pipeline, LLC and delivers into Rocky Mountain Pipeline System LLC and which is charged the Pump Over Fee set forth herein.
